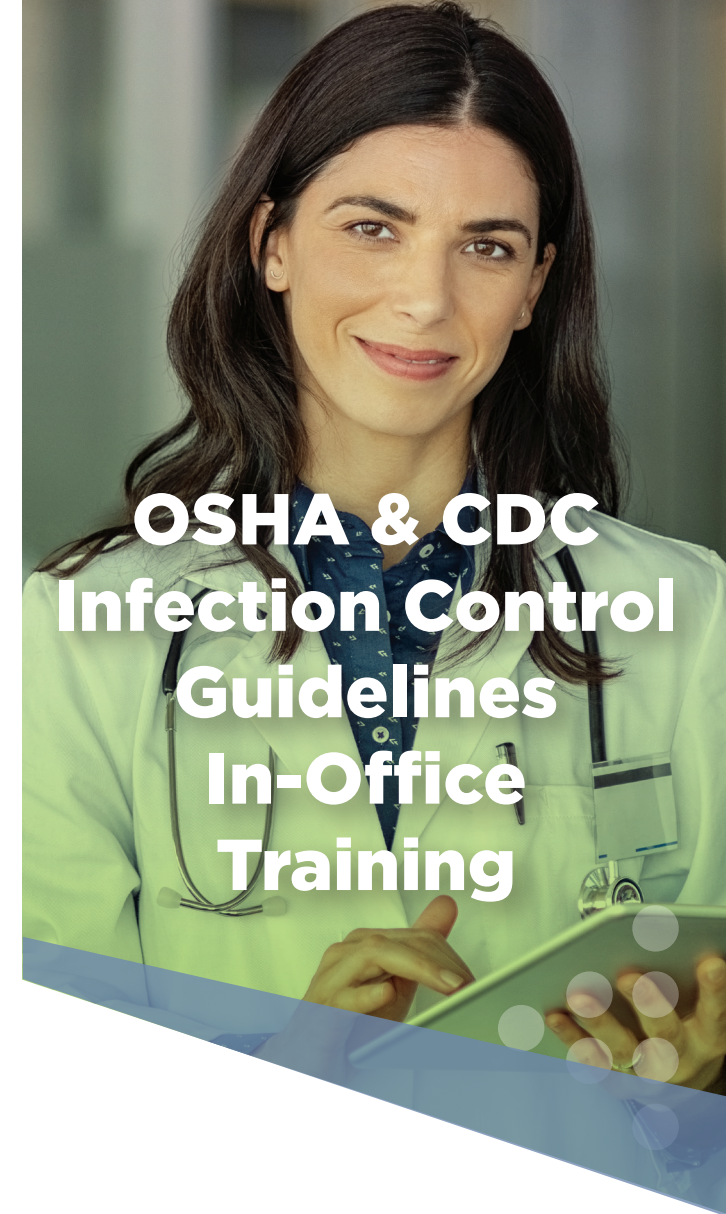

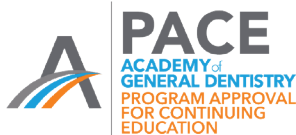
Course Requirements
